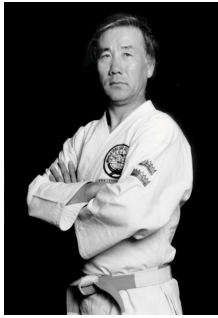


# INVITATION - JUDGING CERTIFICATION
